PAYMENT POLICY

JHDA's tuition is a yearly fee divided into 10 equal payments due the 1st of each month September–June.

All registered families are required to enroll in autopay.

JHDA will charge the card on the account for each families monthly tuition on the 1st of each month.

Families that prefer to pay cash or check must be made before the 1st of the month.

Payments are non–refundable.

Any bounced checks will be charged a \$30.00 fee.

Any declined credit card transactions need to be resolved by the 5th of the month.

If payment is not received by the 5th, a \$10.00 late fee will be added. An additional \$10.00 late fee will be applied **every 5 days** thereafter until the balance is paid in full.

JHDA reserves the right to not allow a dancer to participate in class if they have an outstanding balance.

Each class is scheduled to meet 35 times for the dance year. Tuition is a yearly fee based on the 35 times that classes meet and is divided into 10 equal payments. Holidays and JHDA closings are already factored into your tuition rate.

RECITAL COSTUMES

8

Dancers are assumed to be participating in the annual June recital unless they have **opted out in email.**

Dancers are required to purchase the recital costume from JHDA to participate in the recital.

Costume payments do not include shoes which need to be purchased separately from JHDA.

Tights will be included in your recital package.

All Ballet/Tap Combo classes for ages 2.5–7 will have 2 costumes. All Jazzy Hop classes will have their own costume.

All other classes will have 1 costume per class.

Costume payments are non–refundable and non–transferrable.

Any declined credit card transactions need to be resolved within 5 days of the due date.

If payment is not received by the 5th day, a \$10.00 late fee will be added. An additional \$10.00 late fee will be applied every 5 days thereafter until the balance is paid in full.

JHDA reserves the right to not allow a dancer to participate in class if they have an outstanding balance.

JHDA reserves the right to not order a costume for a dancer with an outstanding balance.

SIZING: JHDA staff will measure dancers in November during class time for their June recital costumes. Costumes are not a custom fit. Measurements are used to size the dancers according to the costume company size chart. We do allow for growing room. Costume exchanges are sometimes available, but not a guarantee. If you wish to exchange your costume size and it is available there is a \$20.00 exchange fee.

TRY ON: Costumes will arrive anywhere between December–May. When your dancers costume arrives we will email the class. Dancers will try their costume on in class on the day stated in the email. All balances with JHDA must be paid in full in order to take your costume home.

LATE ORDERS: We always try our best, but costumes cannot be guaranteed for any dancers who register, add a class, or order a costume after October 15th. If ordering a costume is possible, there are S&H fees for individual orders.

RECITAL PACKAGE & TICKETS

Recital Package:

Every dancer participating in the recital is required to purchase a recital package.

The recital package includes:

- 1 recital theme t-shirt
- 1 pair of recital tights
- Professional recital video link
- Recital practice music
- Recital choreography practice videos

Recital Package Pricing:

\$117 per dancer

\$214 per family with 2 or more dancers (includes a t-shirt, tights, practice music, practice videos, and professional video of recital for each dancer)

Recital Tickets:

- Will go on sale the week of June 7, 2027
- Tickets must be purchased through our online ticketing vendor, Dance Recital Ticketing.
- Ticket prices are tiered by section and will range from \$25–33 per ticket.
- Carefully check that your ticket order is correct before placing your order.
- Recital tickets are non-refundable for any reason.
- There will be multiple recital show times. While we try our best to schedule dancers in multiple classes and siblings in the same recital time, we cannot guarantee it.
- Tickets need to be purchased for every recital time you attend.

All balances with JHDA must be paid in full in order to receive your recital package and recital tickets.

Jazz Hands Dance Academy reserves the right to change the Recital Package and Recital Ticket information and pricing information at any time as needed.

DRESS CODE

SHOES: All dance shoes are required to be purchased from JHDA unless otherwise advised.

Please email us or stop at the front desk to set up shoe sizing and ordering for your dancer.

BABY BALLET & TINY TWO'S: Leotard and tights any color. Hair in a ponytail or clipped out of face.

BALLET/TAP AGES 2.5–7: Leotard and tights any color. Hair in a ponytail or bun.

BALLET AGES 6.5 & UP: Leotard and tights any color. Skirt optional. Hair in a bun.

JAZZ AGES 6 & UP: Leotard and tights any color. Shorts or leggings optional at teacher discretion. Hair in a bun.

TAP AGES 6 & UP: Leotard and tights any color. Shorts or leggings optional at teacher discretion. Hair in a bun or ponytail.

Please label all shoes, dancewear, dance bags, coats, etc. with dancers first and last name.

Please write your dancers initials on the bottom of their shoes.

If an item left behind is properly labeled, JHDA will hold them at the office.

JHDA is not responsible for any lost or stolen items.

SHOES: All dance shoes are required to be purchased from JHDA unless otherwise advised.

Please email us or stop at the front desk to set up shoe sizing and ordering for your dancer.

HIP HOP AGES 5 & UP: Leggings or gym shorts, tank top or short sleeve shirt. Dance attire not school clothes. Hair in a ponytail or bun.

CONTEMPORARY AGES 6 & UP: Leotard or Leggings or gym shorts, tank top or short sleeve shirt. Dance attire not school clothes. Hair in a ponytail or bun.

ACRODANCE AGES 4 & UP: Leotard and tights any color. Hair in a low ponytail or french braid.

Starting October 1st any student that does not have their hair proper for class will be given a hair tie and \$1.00 will automatically be charged to the card on file for each hair tie.



HOLIDAY SHOW

14

Our Holiday Show date is December 20th.

Most of the following classes will learn a holiday dance in their regularly scheduled class starting in October/November:

Ballet/Tap

Jazz

Hip Hop

Some classes may not learn a holiday show dance due to the focus of technique that needs to be practiced in class or for the safety of the dancers with uncertain performance flooring.

While dancers may learn the holiday show dance in class, performing in the show is optional.

Classes able to participate will be announced at a later date.

Holiday Show Fee is \$80 per dancer charged November 16, 2026. Holiday Show includes costume rental, practice video, and production costs.

Paid tickets are not required for this performance and it is free for all audience members to attend.



POLICIES

15

LOBBY POLICIES:

1. Students and family are not permitted to touch or use Jazz Hands equipment or property without permission.
2. Do not tap on the glass, talk to students through the glass, open the door, or enter the classroom while class is in session. It is disruptive to the entire class.
3. Acro mats, chairs, bins and other items are not to be touched or used in the hallway to stand on.
4. Nobody is to enter the classrooms unless it is their scheduled class time.
5. No climbing, standing or jumping on the couch.
6. The office, behind the desk, all closets and cabinets are off limits at all times.
7. No running in the hallway.
8. If you arrive late to class please allow your dancer to enter the room independently or a JHDA team member will assist them. Parents are not to enter the classroom.

CLASS POLICIES:

1. Arrive 5–10 minutes prior to class.
2. Street shoes are not permitted in the classroom.
3. No food, gum, or colored drinks in the classrooms at any time.
4. Dancers should put their jackets and belongings in a cubby.
5. Dancers may bring a water bottle and their dance shoes into the classroom.
6. Cell phones are not permitted in the classroom and must be kept with personal belongings.
7. Bathroom breaks are disruptive to class. Please use the restroom before and after class.
8. All students are expected to respect one another, teachers and staff, the facility and it's belongings as well as the shopping center and fellow tenants.

STUDENT/PARENT/TEACHER COMMUNICATIONS:

- **Contacting Instructors:** Any questions for teachers can be sent via email, studio phone, or schedule a time with our Office Manager. Please do not try to catch an instructor between classes. Class schedules are very tight and our instructors would like to give your questions and concerns the proper attention.
- **Texting & Social Media:** Contacting any staff via text message or social media is not permitted. All contact should be directed to our Office Manager.
- **Opening Class Doors:** Please respect our instructors. All classes are closed session. Do not open the door during class time. When classes are over, the instructor will open the door for the students to exit.
- **Viewing Windows:** For your convenience to watch your child's class we have windows to see into the classrooms. Please do not tap on the glass. Talking to children through the window is a distraction to their learning. It is in your best interest to step away from time to time so that they are focusing on the teacher.

PRIVATE LESSONS:

Dancers are welcome to sign up for private dance lessons in addition to their regularly scheduled classes. Private lessons may be individual or in small groups.

Private lessons are based on studio and teacher availability.

Private lessons are not permitted to be scheduled through the teachers. Contact our front desk.

INCLEMENT WEATHER:

JHDA will notify families via email if there is a closing due to inclement weather.

Students may schedule a make up class for inclement weather days.

Tuition is not discounted or refundable for inclement weather.

POLICIES CONTINUED

ILLNESS/INJURY/ABSENCES:

Parents are advised to keep their students at home for the following conditions:

- Fever or vomiting.
- Infected skin or eyes or an undiagnosed rash.
- Severe itching of body or scalp, lice.
- Hand, Foot, and Mouth Virus.

We recommend that a dancer with an injury still comes to class and minimizes movements or sit and watch with doctor's approval to not miss any material.

If a student will be missing 2 or more consecutive weeks of class, please contact the studio office. The office staff will relay the information to the instructors.

Students may attend a class not in their registered curriculum to make up for the missed class. Make up classes must be used within 2 months of the absence while remaining enrolled. Tuition is not discounted or refundable for any missed classes. Make up classes need to be scheduled and confirmed through the front desk. Scheduling make up classes is at the discretion of JHDA.

Students with excessive absences may need to change classes and/or private lessons to catch up on what they have missed. Teachers cannot continue to review previously taught material.

SCHEDULING:

JHDA reserves the right to change the schedule at any time. Classes are shown by age, however placement is also according to level/ ability/ experience. A JHDA staff member will be happy to assist you with the best classes for your child.

Any class may be canceled due to insufficient enrollment. Any class with 4 or less kids is considered a private class and will be priced accordingly. Students are required to enroll in Ballet in order to take Jazz, Pointe, and/or Contemporary.

Students are required to take private lessons if they are enrolling in a style they have not trained in before. Students are required to take private lessons if they enroll after November 1st to learn any technique or skills they missed in the beginning of enrollment.

POLICIES CONTINUED

NO TOLERANCE:

JHDA prides itself in creating a fun, friendly, kind, and respectful environment for its staff, students, and parents.

JHDA has a strict no tolerance policy for anyone who is disrespectful or rude or cannot follow any of the policies provided in this handbook.

This includes but is not limited to slander or defamation of character verbally, via email, via social media, or via text messages of any kind.

JHDA reserves the right to discontinue providing lessons and permanently dismiss any dancer and their family who does not abide by these policies.

DISCONTINUING:

If you'd like to discontinue a class it is required to submit in email/writing.

Your reservation in that class will be removed at the end of the month in which JHDA receives a written notice. Absences must be made up within the time you are enrolled at JHDA. All make up classes expire once you discontinue.

You are responsible for tuition payments for the remainder of the month.

For example, if you submit your discontinuation on October 15th, you are responsible for tuition payment through October 31st and your spot in class remains through October 31st.

November 1st your discontinuation goes into effect and you will not be charged for November tuition.

Registration Fees, Costume Deposits and Balances, Recital Packages and any other items are non-refundable.

PHOTOGRAPHY & VIDEO RELEASE

JHDA uses photographs and videos of its own dancers in its marketing and promotional materials. You are granting JHDA full permission to take, use, reproduce, and publish photographic, video, and digital images of your student (collectively, “Images”) for JHDA marketing and promotional purposes during and after the student’s participation in JHDA programs. Further, you acknowledge that JHDA shall be the exclusive owner of all rights, including copyright, in the Images, and you irrevocably transfer, assign, and otherwise convey to JHDA your entire right, title, and interest, if any, in and to the Images and all copyrights and other intellectual property rights in the Images.

IF YOU WISH TO OPT OUT: If you do not wish to have photographs or videos of your student(s) used in marketing and promotional materials by JHDA or otherwise want this Photography and Video Release to not apply to your student(s), you must indicate that you are opting out in the appropriate online box. Specifically, new registrants must type “I OPT OUT” in the appropriate box on the Web Registration Form. Current families must log into their portal, go to the My Account tab, and type “I OPT OUT” in the appropriate box.
